Dear Customer,

Liberty Magona S.r.l., as Data Controller, hereby informs you that, pursuant to Article 13 of the EU Regulation 2016/679 on the protection of personal data (hereinafter referred to as the Regulation), for the establishment and execution of ongoing contractual relationships, it is in possession of or may subsequently come into possession of information relating to you.

Your personal data will be processed in the following manner and for the following purposes.

<b>TYPES OF PERSONAL DATA PROCESSED</b>	The following personal data may be processed: a) personal data, b) purchases and orders, c) economic and financial data, d) tax data, e) contact data, f) solvency data, also obtained from third-party companies.
<b>PURPOSE OF PROCESSING</b>	Your personal data may be processed for the following purposes: <ul style="list-style-type: none"> <li>to conclude and implement pre-contractual and contractual measures to which you are party, including customer service management and after-sales support</li> <li>fulfilment of obligations towards the state financial administration, accounting and administrative management, management of existing business relations and management of disputes</li> </ul>
<b>LEGAL BASIS</b>	The legal basis for the processing is the performance of a contract to which you are a party or the execution of pre-contractual measures taken at your request, as well as the fulfilment of obligations under applicable law and the legitimate interest of the Data Controller in verifying your creditworthiness.
<b>CONTRIBUTION</b>	The provision of the requested information is necessary to fulfil legal and contractual obligations; therefore, any refusal to provide it will make it impossible for the writer to execute the contract.
<b>STORAGE TIMES</b>	The data will be retained for the period of time necessary for the pursuit of the aforementioned purposes and in any case no longer than the retention periods stipulated by law.
<b>RECIPIENTS OF PERSONAL DATA</b>	The data will be processed by staff in charge, appropriately instructed and operating under the authority and responsibility of the owner. Some of the information may be disclosed to the following parties: <ul style="list-style-type: none"> <li>Public bodies (tax offices and other bodies);</li> <li>Law firms or consultancies to which the Controller has given a specific mandate;</li> <li>Computer support and maintenance companies or suppliers of computer storage systems;</li> <li>Other parties or companies that carry out activities instrumental to the purposes indicated above on behalf of the Data Controller.</li> </ul> A detailed list of these subjects is available at the Data Controller's offices and will be provided upon your request by writing to the following e-mail address <a href="mailto:privacy.magona@libertysteelgroup.com">privacy.magona@libertysteelgroup.com</a>
<b>RIGHTS OF THE DATA SUBJECT</b>	We also inform you that, in relation to the data itself, you may at any time exercise the rights provided for in CHAPTER III of the Regulation. In particular, you have the right to ask the Data Controller for access to the data concerning you, their rectification or cancellation, the integration of incomplete data, the restriction of processing; to receive the data in a structured, commonly used and machine-readable format; to revoke any consent you may have given and to object in whole or in part to the use of the data, as well as to exercise the other rights recognised to you by the applicable regulations.
