19.2 Nothing in these Conditions shall create, or be deemed to create, a partnership or joint venture or relationship of employer and employee or principal and agent between the parties and no employee of the Supplier shall be deemed to be or have become an employee of the Buyer.

19.3 No purported alteration or variation of these Conditions shall be a unless it is in writing, refers specifically to the Contract and is signed by authorised representative of each of the parties.

19.4 The waiver by either party of any breach of these Conditions shall not prevent the subsequent enforcement of that provision and shall not be deemed to be a waiver of any subsequent breach of that or any other provision. Any waiver of any breach of these Conditions shall be in writing.

19.5 If at any time any part of these Conditions is held to be or becomes

is a if at any time any part of triese committees there to be or becomes viole or bitherwise unenforceable for any reason under any Applicable Law, the same shall be deemed omitted from these Conditions and the validity and/or inforceability of the tremaining provisions of these Conditions shall not in any way be affected or impaired as a result of that omission.

19.6 Any notice given under this Agreement shall be in writing and d fax or registered post or e-mail to the address of the party specified in or such other address as is notified to the other party from time to time and delivered by fied in the Order 19.7 The Supplier shall not directly or indirectly, for the duration of the Contract and a period of six (6) months thereafter, employ, solicit or entice away, or attempt to employ, solicit or entice away, any personnel of the Buyer.

20. Law and Jurisdiction:
20.1 These Conditions, the Contract and any dispute or claim arising out of or in connection with them shall be governed by, and construed in accordance with the laws of England and all disputes or claims arising out of or relating to these Conditions and/or the Contract shall be subject to the exclusive jurisdiction of the English Courts to which the parties irrevocably submit
