## **LIBERTY Ostrava produced tubes for one of the world's largest oil fields**

**Ostrava March 31, 2020 – In late March LIBERTY Ostrava completed a significant order to manufacture 11 km of seamless tubes for the West Qurna oil field in the south of Iraq, which is one of the largest oil fields in the world. The tubes are made of high quality steel with high resilience.**

*“Projects for oil drilling companies are among the most demanding both from the technical point of view and the complete project execution. The fact that we have successfully completed the order is an evidence of the quality of our products and service,”* says Martin Klosko, head of tubular plant at LIBERTY Ostrava.

Unlike other types of products, the OCTG have to comply with the most stringent parameters and undergo a wide range of testing which confirm, among other things, that the material used for their production can weather even an acid environment rich in sulphide. The Ostrava tubular mill delivered to Iraq nearly 11 km of seamless tubes made of vacuum degassed steel which are equipped with an insulation to resist temperatures of up to 80°C.

*“The quality of the produced tubes had to be confirmed by a wide range of tests which were key for obtaining the order. The tests were even conducted in the presence of two grantee companies nominated by the final user,”* adds Libor Kubíček, specialist in tube testing at LIBERTY Ostrava.

The West Qurna oil field (Phase II) containing up to 14 billion barrels of oil stretches at an area of 340 square kilometres and falls under the state-owned Iraq National Oil Company which deals in oil drilling in the south of Iraq in cooperation with Lukoil multinational corporation.

***LIBERTY Ostrava is an integrated steel business with an annual production capacity of approximately 3.6 million tonnes per annum serving construction, machinery and oil & gas industries. The company is a domestic leader in the manufacture of road barriers and tubes. In addition to the Czech market, it supplies its products to more than 40 countries around the world.
