1. Within adhering to legislative requirements for the quality, environmental protection, H&S of company staff and energy management, by continuous improvement:

 - to support and implement proposals for energy demands elimination.
2. To communicate and cooperate with the local administration, public and customers and thus to create a good image of the company, to provide objective information on the activities in the area of energy management and on impacts of the companies on the environment and safety of the citizens.
